Please read carefully this Privacy Notice (the "**Notice**"), which describes our practices regarding the processing of your personal data in accordance with the General Data Protection Regulation (the GDPR, i.e. Regulation 2016/679 of the European Parliament and of the Council). This Notice applies to persons who use the services of the Data Controller as consumers (**you**). It describes how the Data Controller collects, uses and, in certain cases, shares your personal data with third parties and provides information about your "data subject" rights in relation to data processing.

The Data Controller is committed to protecting the personal data and privacy of individuals visiting this website. This notice and privacy statement is primarily concerned with the confidentiality and protection of personal data of customers and newsletter subscribers via the Internet, but also includes visitors to the site. Personal data means any information relating to a natural person who can be identified, directly or indirectly, by reference to an identification number or to data relating to that number. In the event that the Site Owner collects your personal data, the collection will be carried out in a transparent and confidential manner.

Your personal data is information that allows us to identify you, such as your surname, first name, nationality, telephone number, postal address, e-mail address. Your personal data is collected voluntarily by the owner when you browse the site, indicating in each case the information that you need to provide in order to achieve the purpose. If you do not wish to provide this data, you will not be able to access certain functions and services of the site. The collection of optional data serves to understand user needs and to improve the website and its services.

### **What is a Cookie?**

A cookie is a small packet of data that internet services store in your browser. It is an essential technology for an efficient and modern online service that is supported by all browsers today.

### **How is a cookie created?**

First the client machine sends a request to the server. The server then generates a unique identifier and stores it in its own database, and sends the cookie back to the client with all the information. The returned information cookie is stored on the client machine.

### **How is the Cookie useful?**

When the client machine contacts the server again, it will have already paired the cookie that was previously created and stored. The server compares the contents of the cookie it received and the cookie it stored. This makes it easy to identify e.g. the logged in registered user. Without this, for example, it would not be possible to log in to a website.
